#### 1. Participation at your own risk

By joining the event you accept that your participation in FOOTBALL DREAMS tests is at your own responsibility and your own risk in every respect. You accept that you cannot claim any kind of damages, indemnification or any other compensation for personal injury, damage to property or any other loss, including any kind of indirect loss in connection with your participation in the event, from organizers, sponsors, staff or partners, unless you are subjected to any kind of injury or loss due to gross negligence on the part of organizers or their employees. The organizers cannot be held liable for negligence displayed by independently participating third parties or the local authorities prior to, during, or after the event. If you are injured in any way due to your participation in the event, and as a result are unable to go through with your stay on the filed as planned, you are also prevented from claiming damages, indemnification, or any other kind of compensation.

#### 2. Medical Help

Organizers will ensure that qualified medical professionals are on hand to assist competitors during the event, only when the competitors will be in Aspire for the final test. However, if any treatment is not or cannot be carried out by this medical personnel, it will be a matter between you, the local medical services, and your travel insurance. You cannot hold the organizers responsible for any errors or any negligence caused by local medical personnel.

#### 3. Health Insurance

Organizers will provide all participants traveling to Aspire for the final test, an adequate personal and travel insurance before traveling to Qatar. Such insurance cannot be taken out in Qatar, and must be purchased before arriving in the country. The organizers will not provide all participants any insurance to participate in the event, and recommend all participants to take out an insurance for injuries in their country.

#### 4. Sponsors

Without the assistance and support of sponsors of the event, such a competition would not be possible. Therefore, in order to protect their interests and investment, any competitor wishing to wear or carry any form of advertising, other than normal equipment logos, must obtain written permission from the organizers in advance of the competition date.

#### 5. Film & Video

Family, friends and other spectators are very welcome to take photographs or make video recordings for private use. Professionals photographers must obtain written permission from organizers prior to the competition. All rights in relation to the event name and logo are the property of the event, and permission to use the name FOOTBALL DREAMS or pictures from the event for commercial purposes, must be obtained in writing from the organizers prior to use. With this agreement the participants allow the organizers of the event to record total or partial part of their participation in the event, through photographs, movies, TV, radio, video or other known or unknown media, and the participants give up all the rights concerning their business and publicity utilization that they consider to use, without right to receive any economic compensation to the participants.

#### 6. Travel and Housing expenses

The competitors will not be charged for any travel or housing expenses if they are selected.

#### 7. Force Majeure

In the case of any situation outside the organizers control, such as political unrest, weather or like conditions and field inability caused by any reason the following will happen:

Should the incident occur before or during the date of the event, the participants will be led to other places if it's possible to find them. Organizers will try to offer to all participants an alternative competition date or field.

#### 8. Additional Notes

These conditions, in particular the exclusions of liability in clauses 2-3, form part of your agreement with BSM (Bonus Sports Marketing) and ASPIRE, the organizers of the FOOTBALL DREAMS.

#### 9. Choice of Law and Venue

By joining the event, you accept that any dispute in relation to your participation in the event will be subject to (country) law.

The fulfillment of this registration form means the respect and the agreement on the organization's instructions and decisions. In case of major infringement, the competitor admit and acknowledge that they could be ousted from the selection process.
